1. DEFINITIONS

- **a) Descubre Paris:** is a business located in Thiais, France, registered under the RCS Number 847 667 664 R.C.S Créteil, the Company Purpose is Tourism Related E-Commerce.
- b) Descubreparis.com: Is the website authorized by Descubre Paris to present information to travelers around the Spanish-speaking and English-speaking world who wish to visit Paris. In this website we give details on our offers and provide web users a wide array of information on the city. We have a blog where the author expresses her opinions, ideas, and suggestions about how to best visit Paris. She shares practical and historical information as well as tips and tricks to inspire and contextualize the tourist. In our website we provide for the Users or Clients an online store (E-shop), where we sell three types of guides: a practical guide, a detailed guide, and a customizable guide to visit Paris depending on the amount of days per visit.
- c) The Client: Any legal person, business, organization or other type of legal entity that successfully purchases products from **Descubre Paris**, on the website DescubreParis.com.
- **d) Receipt:** Document that confirms the payment of the Product and displays the unit price, applicable discounts, Sales Tax if applicable, and the total amount paid.
- e) Practical Guides: digital, downloadable guides with specific, practical, and useful information that aides in making decisions on how and when to visit Paris, how to visit specific places or particular themed guides around the city.

- **f) Detailed Travel Guides:** Digital, downloadable guides with predesigned circuits where the tourist is guided step-by-step to discover the most iconic places around the city, without having to worry about the how since every step is clearly detailed in the document, with historical information as well as prompts and anecdotes.
- **g) Personalized Travel Guides:** Digital, downloadable guides that are customized for the traveler according to their specific needs, dates of travel, time of arrival, place of staying, preferences, priorities and wishes. These guides are made-to-order with a specific delivery timeline.
- **h) R&C:** Requests or complaints a user presents through the website or the contact email provided.
- i) Product: Any good or service advertised or offered by Descubre Paris.
- j) User: Any person that accesses or uses the website Descubreparis.com
- **k)** The terms "us", "we", "ours" will refer to **Descubre Paris**, the terms "you" will describe both Users and Clients, depending on the context.

2. DESCRIPTION AND ACCEPTANCE OF TERMS

These Terms and Conditions of Buy and Sell, from here on referred to as T&C or The Agreement, regulate the use of the website www.descubreparis.com and of any of the contents **Descubre París** provides for any internet user.

The T&C contain information related to your rights, limitations to these rights, obligations, applicable laws and the jurisdiction in case of legal dispute, among other things. This document constitutes a valid, unique and comprehensive agreement between the parties on the terms, conditions and restrictions of the obtained Products and it explicitly excludes any other agreement be it electronic, oral or written between yourself and **Descubre Paris**, without prejudice to what is indicated in Chapter 15 of the agreement.

Where **Descubre París** provides details on third-party vendors rates, this information is provided merely as a reference guide. Every product consists of a protected PDF document, the size of which varies according to the amount of days or the type of Product selected by the Client. This information is specified in the detailed description of each product in the Online Store (E-Shop).

The Client or User accesses the Online Store (E-Shop) and chooses the Product that most interests them from the selection provided on the main page, which is organized by categories and can be filtered by a set of given options.

To purchase the Product the Client or User must add it to the cart. To pay, they must click "GO TO CART" where they can verify their selection. 5. PRICES

- a) The prices published in **Descubre Paris** are presented in EUROS (€).

In the first case, the Client with a PayPal account may input their PayPal account information and pay as usual through the platform. In the second case, if the Client does not have a PayPal account they must follow the instructions presented and provide the information needed to realize the payment.

Once the payment has been realized, the Client will immediately receive an email with a summary of their purchase or order, payment confirmation, and access to the link where they can download the Product they acquired. They Client may download the file up to two (2) times in a period of no more of 365 days starting from their day of purchase (whichever happens first).

Successful payments for Guides are not adjustable, endorsable, subject to revision or refundable, regardless of the season.

Through this document, the Client accepts to receiving automatic digital receipts of their purchases. They must verify the details in their confirmation receipt and contact us as soon as possible if they find any inconsistency.

Electronic receipts will be sent automatically as a PDF. If for whatever reason the Client does not receive their Receipt, they can email us at ventas@descubreparis.com with the subject line: Request of Receipt Copy. In the message they must indicate the name of the person who placed the order, date of purchase, purchased Product and Order Number. **Descubre París** will send the Receipt via E-mail in no more than ten (10) working days following the communication.

Braintree and PayPal's terms of services may vary according to the Country where the Client is based and **Descubre París** has no influence over this.

The Client uses said platform under their complete responsibility, which is why we recommend reading Braintree and PayPal's T&C's and Privacy Policies since they may have policies and regulations regarding personal data that may be different from those covered in our website.

7. AVAILABILITY

All of our Products are immediately available and, since they are digital copies, they generate no extra shipping fees.

Our online store (E-Shop) works 24 hours per day, 7 days a week, during the 365 days of the year.

However, **Descubre París**, cannot guarantee that the access will be entirely uninterrupted or without errors. Descubreparis.com may become unavailable temporarily without warning in case of system failure, maintenance or any other reason beyond our control. The unavailability due to system updates or upkeep does not give the Client right to any sort of reimbursement or compensation.

Likewise, the Client or User acknowledges that the availability and quality of service may vary as a result of several factors, such as: the device being used, geographical location, available internet bandwidth and/or their internet connection.

In case of a problem when downloading the document, the delivery will be done via email within no more than three (3) working days starting with the date of purchase and after payment verification.

Descubreparis.com may make use of cookies or similar technologies that will adhere by what is established in our Cookie Policies, which is an integral part of these T&C and is accessible at all times for the Users or Clients.

14. JURISDICTION AND GOVERNING LAW

The Client acknowledges that if they have a question or complaint with Descubre París, due to or related to the Products offered here, they will communicate first with us via Email to try to bring you a solution.

If Descubre París does not provide a satisfactory answer to your complaint within 60 calendar days, and your place of residence is in the European Union, you may turn to the alternative conflict resolution included here: http://ec.europa.eu/consumers/odr/.

In the event of both parties not reaching an agreement in the above manner, all contractual disputes or non-contractual ones will have to be resolved preferably by the appropriate courthouses in France. However, their jurisdiction is nonexclusive. This means that if the Client is

a consumer resident of the EU, they may also claim their rights according to these T&C in France as well as in their country of residence, alternatively.

Since the Personalized Travel Guides offered by Descubre París are made to order, you must carefully read the following special conditions.

Any detail not specified in this chapter will operate by what is indicated in the texts of the T&C.

a) Buying Process

- (i) The Client or User contact **Descubre París** through the form available in the website letting us know their interest in obtaining a Personalized Travel Guide.
- (ii) **Descubre París** will return the email asking for information on the details of their trip.
- (iii) **Descubre París** will issue a quote in no more than seven (7) business days, from the day when the Client/User sends the requested information.
- (iv) If the quote sent by us is of your interest, you must answer via email citing expressly that you accept the offer. Keep in mind that each quote is valid for six (6) months.
- (v) **Descubre París** will ask the Client further questions to obtain relevant information for the creation of the Personalized Travel Guide.
- (vi) Once the Client sends their answers via email, we will send you an Invoice and the T&C.
- (vii) The Client makes the payment of the Invoice.
- (viii) Once the client has made their payment, they will receive an email with a summary of their order, payment confirmation, and the dates in which they will be receiving the link to download the Product they acquired.
- (ix) In no more than twenty (20) business days, starting with the day when the Invoice was payed, **Descubre París** will send the Client the instructions and links where they can download the **Personalized Travel Guide** they acquired.

b) Price and methods of payment

- (i) The Price of the Personalized Travel Guides will be determined by **Descubre París**, according to the specifics and interests mentioned by the Client or User when they first contact us.
- (ii) Payment will be processed through the platform PayPal, following the general instructions in chapters 4 and 6 of the T&C, where it corresponds.
- (iii) In such case where the Client changes some of the terms of their trip, after the Invoice is sent out, they recognize and accept that the price of said Invoice may vary at the discretion of **Descubre París**.
- (iv) Descubre Paris's services are limited to the creation of the Products indicated in the website and these T&C. However, in the specific case of the Clients that acquired Personalized Travel Guides and ask of Descubre Paris that they purchase tickets for some establishments, Descubre Paris may provide this service, but is not obliged to do so. In this case, the Client will assume the extra cost of these tickets, according to the rates and procedures that Descubre Paris state at the moment.
